- Liz Cheney Rides her Broomstick to Slaughter Bears, Again

Wyoming Congresswoman Liz Cheney and Senator Mike Enzi have again introduced a bill that would legislatively strip Yellowstone grizzly bear of protections that were restored last fall by a federal judge. The bill has little chance of passing the House, but we should not ignore prospects for the bill being tacked onto a must-pass piece of legislation. Please Help Protect Wolves – And, Grizzlies Could Be Next

Last week, Acting Secretary of the Interior David Bernhardt announced that the U.S. Fish and Wildlife Service will soon propose a rule to administratively delist gray wolves throughout the lower-48 states and return management of the species back to the states – in defiance of rulings by federal judges. The rule would not only undermine the rule of law, but also undermine wolf recovery, which is one of our nation's great conservation successes. Only Mexican gray wolves would remain listed under the Act.

Wolves are icons of our landscape and their presence is vital to maintaining the health of their native ecosystems. In Idaho, Montana, and Wyoming, where wolves have already lost federal protections, trophy hunters, trappers, and others have killed nearly 3,500 wolves just since 2011.

Groups Sue to Stop Attempted Grizzly Bear Hunt by Wyoming

Conservation groups put the government of Wyoming on notice that they will sue over a recent bill passed by the state legislature authorizing a grizzly bear hunt in defiance of a federal court order reinstating Endangered Species Act protections and prohibiting state-sponsored trophy hunting. The Bob Jackson interview and blog underscore that Wyoming has been out-of-control for a long time, a throw-back to the regressive 1800s politics of the Confederacy, and in need of a good spanking.

Forest Service Whines about Selway Bitterroot Grizzly Bear Recovery

Grizzly bears have been starting to make their way back into the Selway Bitterroot ecosystem of central Idaho, a vast wildlands bigger than either the Northern Continental Divide or Greater Yellowstone ecosystems. Twenty years ago the federal government proposed recovering grizzlies in this ecosystem through mechanical reintroduction, but the process blew up after G.W. Bush was elected president.

Last fall a grizzly that had nearly made it to this recovery area was removed from the Bitterroot Valley after digging earthworms on a golf course – hardly a "problem." But the Forest Service

has whined, and other regressives are complaining too. Confusion abounds. More on the Selway Bitterroot below.

Mark Your Calendar: *Grizzly Bears for the Clearwater, Beyond the Great Divide*On April 11th and 12th, Dr. David Mattson and Louisa Willcox will present a program, sponsored by Friends of the Clearwater in Moscow, ID. These Idaho and Montana wildlands are now the most extensive of any in the lower-48 states, with the promise of supporting as many grizzly bears as we currently have in the Greater Yellowstone and Northern Continental Divide Ecosystems.

There once was a thriving population of grizzly bears in the Salmon-Selway-Clearwater ecoregion, but all were killed during a century-long onslaught by European settlers.

This program will touch on the past, present, and future prospects for grizzly bears "beyond the Great Divide," and how natural colonization could lead to durable recovery of grizzlies in this part of the world.
